

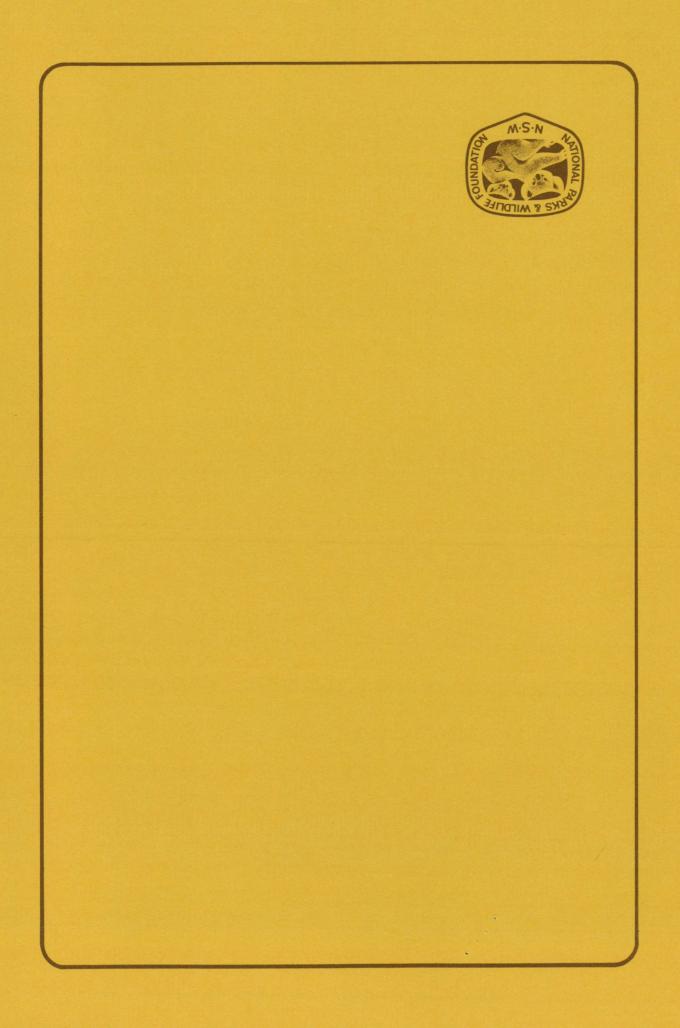

REPORT OF THE EXECUTIVE BOARD

FOREWORD BY THE PRESIDENT

Following a most successful campaign during the past year, the Foundation has raised approximately \$1.2 million since its This is a very creditable effort inception. and is an example of the concern being displayed by industry and commerce and individual members of the public for the provision of national parks and reserves. The campaign culminated with a residential appeal which was not only financially successful but showed that the public were willing to play their part in contributing towards their own well-being and future recreational needs. A most generous gift of \$100,000 from The Boral Foundation for Willandra National Park will be a major factor in providing a most welcome addition to the parks system.

The Foundation has now allocated over \$1 million to projects and achieved an expenditure of about \$600,000. Expenditure tends to lag behind allocations as funds have been allocated mainly for the acquisition of land. This is often a protracted process. The Foundation's funds have enabled the National Parks and Wildlife Service to acquire key areas of land as they became available. The Service has been able to add to the land initially acquired and thus, both organisations have facilitated the creation of valuable parks and reserves such as Myall Lakes, Bouddi, Sturt in north western N.S.W., Willandra and Yathong. Other projects have been supported such as the development of Captain Cook's Landing Place at Kurnell and initial work on Sydney Harbour National Park.

The project list has been revised as a result of experience during recent years. Areas for the application of funds have been widened and the Foundation's participation in their developments clearly illustrated. Details are included later in the Report.

The Foundation's committee structure has been modified to fit in with the campaign control organisation. The latter is created each year to seek business gifts, and donations from individual members of the public through a residential appeal. The Publicity and Programme Committees are now part of the campaign organisation and have been deleted from the Foundation's list of standing committees.

A noted conservationist, General Charles A. Lindbergh visited National Parks in N.S.W. as a guest of the Foundation during August 1972. He met Trustees and gave a press conference. During February 1973, the President of the World Wildlife Fund, H.R.H. The Prince of the Nederlands, (Prince Bernhard) had an informal discussion with Trustees during a visit to Australia. Dr. Russell G. Mawby, President of the Kellogg Foundation in USA visited National Parks as a guest of the Service and Foundation during April 1973. These visitors were most helpful in enabling the Foundation to compare its activities and accomplishments with overseas organisations.

During the year, Dr. D.F. McMichael was appointed as Secretary of the Department of the Environment and Conservation. His contribution to the creation of the Foundation and the work of the Service was outstanding and our gratitude and best wishes for continuing success go with him for his new endeavours in the Commonwealth sphere. A hearty welcome is extended to his successor Mr. D.A. Johnstone, Director of the National Parks and Wildlife Service. Mr. Johnstone has become a Trustee of the Foundation and Mr. G.M. King, Assistant Director (Administration) of the Service will replace Dr. McMichael as Honorary Secretary and has also become a Trustee. Our organisation has been strengthened by Mr. A.F. Little, Mr. P.H. Pigott, Mr. T.E. Pollitt, and Mrs. Helen Price joining the Foundation as Trustees. During the year Sir Vincent Fairfax, Mr. R.K. Hart and Mr. J.G. Wilson resigned as Trustees. Their interest and support has been very much appreciated particularly in the formative years of the Foundation.

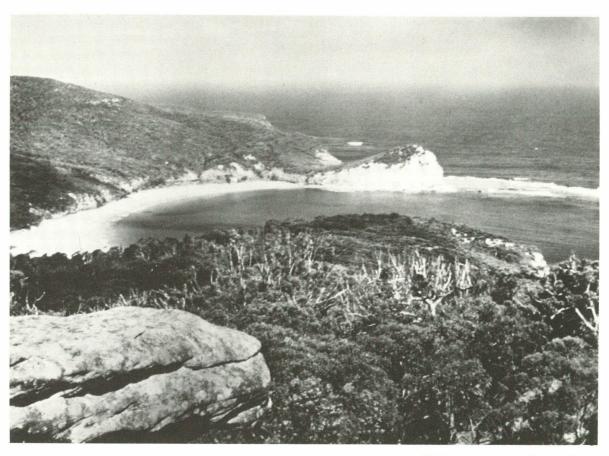
Report of the Executive Board (continued)

In conclusion, I would like to thank all members of the Foundation for their support during the year. We are particularly grateful for the continued assistance of the Rural Bank, and our Honorary Auditors, Messrs. Yarwood Vane & Co., and to K.G. Murray Publishers Holdings Limited and the National Parks and Wildlife Service in the preparation and printing of the Foundation's publications.

PROJECTS:

The 1972/73 fund raising campaign raised \$383,705. As the Foundation has commitments for the provision of funds for the acquisition of land for Myall Lakes and Willandra National Parks and Bouddi State Park, part of this amount was absorbed for these purposes. The campaign has enabled Angourie National Park to be established and permitted the addition of an important area to Morton National Park.

The revision of the Project List with the emphasis on the acquisition of land has given greater flexibility in the allocation of funds. It is appreciated however, that some donors may wish to sponsor items or areas of specific interest and a separate leaflet has been prepared as a guide for this purpose.

Report of the Executive Board (continued)

FUND RAISING AND PUBLICITY:

In early 1972, the Foundation's Fund Raising Advisory Committee considered and approved a fund raising blueprint which suggested that, under annually appointed campaign leadership, a multi-faceted appeal approach be taken. The plan provided for a Business Gifts Division, a Residential Appeal Division, and a Special Promotions Division all approaching their respective audiences concurrently. All activities were to be conducted under an umbrella of slowly increasing publicity building to a climax in late February 1973 during the public appeal period.

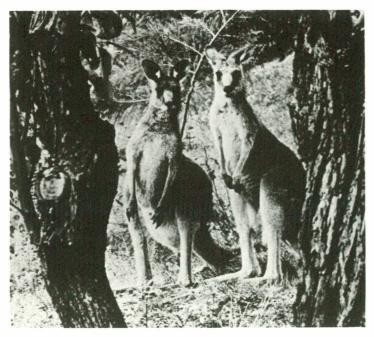

The success of the appeal was measured not only in financial results but the great amount of public awareness generated by the appeal.

As this was the first large scale public appeal for National Parks the return of receipt books used by collectors was slow and unused receipt books are still being returned. Special emphasis will be given to this aspect in the next campaign.

One of the highlights of the attendant appeal publicity was a "Youth For Wildlife" poster contest jointly sponsored by "The Sydney Morning Herald" and The Bank of New South Wales, in conjunction with the Foundation and the Service.

A concentrated publicity programme over several months, encouraging young people to enter the contest did much to acquaint the public to both the problems and opportunities in the area of general conservation.



The contest received some 12,000 applications and winners were announced coincident with the public appeal for maximum exposure. The prizes awarded to winners consisted of guided visits of varying duration to National Parks throughout Australia.

One of the most important rewards of the appeal was the generally favourable reactions of people who endorsed the Foundation's prime objective – the acquisition of land while there is still time to do so.

Report of the Executive Board (continued) **BUDGET:**

During the financial year 1972/73, the Foundation spent \$157,710 on projects and \$58,598 on administration, office expenses and campaign costs. The campaign for 1972/73 permitted an amount of more than \$120,000 to be spent on additional projects for acquisition of land for the establishment of Angourie National Park and an extension to Morton National Park.

Future campaigns should enable increasing amounts to be allocated.

SCIENTIFIC RESEARCH

Funds are required to assist in the acquisition of information which is essential for wildlife management and land use. It is especially necessary to study kangaroo populations and related environmental problems.

Funds have been donated specifically for this purpose \$9,889.

EDUCATION

The first stage of a School of Nature Conservation in the Blue Mountains will be provided through Service funds but an additional amount of approximately \$400,000 is required to provide adequate facilities. A Visitor's Centre is urgently required at Govett's Leap in the Blue Mountains at an estimated total cost of \$250,000. A Mobile Display Unit has been donated by the Rural Bank at a cost of \$15,500.

GUIDELINES

From the outset it was estimated that at least \$5,000,000 must be raised by the Foundation to make a significant impact on the expansion of the parks system. More than \$1,000,000 has been donated already and all available funds have been allocated to projects.

To acquire land in the coastal areas to forestall development will absorb at least \$1,000,000.

In the western areas, funds are required for the acquisition of land representative of various types of locations and conditions. It is vital to be able to take advantage of opportunities as they arise as properties become available for sale, expiration of leases etc. At least \$500,000 could be required during the next few years.

Acquisition of land for mountain areas is proceeding mainly by negotiation between Government Departments but the acquisition of some freehold land will be necessary. An amount of \$500,000 could be required.

Scientific Research has been initiated on a modest scale. It is desirable to expand this activity to cover many aspects of the natural environment as an aim secondary to the acquisition of land.

The Foundation's funds are now fully committed to projects and reserves must be built up to give flexibility. As the Service's estate increases the requirement for development to permit its use by the public and for conservation becomes more urgent. The Foundation's funds are used sparingly for this purpose as the acquisition of land has the highest priority at this stage.

REPORT BY THE NATIONAL PARKS AND WILDLIFE SERVICE

In October 1967, when the National Parks and Wildlife Service was created, its estate was just over two million acres. As at 30th June 1973, it was more than four million acres. A highlight of the dramatic increase in area is the inclusion of 13% of the coastline of New South Wales.

The Foundation has played a significant role in this development and the Service is pleased to record its gratitude for the continuing financial support it is receiving.

During the year the Service's estate was expanded by the establishment of six new National Parks, nine Nature Reserves, two Aboriginal Areas and one Historic Site totalling in area 81,579 acres (33,014 hectares). In addition 529,818 acres (214,410 hectares) were added to existing Parks and Reserves.

Acquisition of Yathong Nature Reserve, for which the Foundation contributed \$95,000, and the purchase of an adjacent property "Glen Lea", now being negotiated, will give the Service a total area of 216,700 acres (87,695 hectares) in this region. The research programme to be implemented here, the running of sheep and kangaroos together, will investigate the viability of this type of farming.

Sturt National Park, the nucleus of which was created by the purchase of Mount King Station with funds of \$80,000 provided by the Foundation, is being enlarged by the Service and current negotiations are expected to increase the area to 730,456 acres (299,689 hectares).

The Foundation has allocated \$102,843 for acquisition of a property at Willandra in central New South Wales covering an area of 48,000 acres (19,400 hectares). Of this area, 32,100 acres has already been reserved as Willandra National Park and the remainder is expected to be added to the Park in the near future.

Landscaping and other works on Clark and Shark Islands, to be part of the proposed Sydney Harbour National Park, are expected to cost in excess of \$100,000. To date, the Foundation has made available \$6,000 for improvements to Clark Island.

An undertaking by the Foundation to provide funds amounting to \$404,821 enabled the Service to acquire key areas to forestall building development which would have marred the scenic values of Bouddi State Park.

Bouddi is a typical example of how key holdings, acquired through the help of the Foundation, can act as a catalyst for the eventual expansion of Parks and Reserves. In these circumstances, prompt action is vital or the opportunity is lost.

In our opinion:

FUNCTIONS OF THE NATIONAL PARKS AND WILDLIFE SERVICE

The National Parks and Wildlife Service is the N.S.W.'s Government agency responsible for nature conservation generally, and in particular for the establishment and management of areas of land as National Parks, State Parks, Historic Sites, Nature Reserves and Game Reserves.

AIMS AND OBJECTIVES OF THE NATIONAL PARKS AND WILDLIFE FOUNDATION (N.S.W.)

The Foundation was created to provide a financial arm to the National Parks and Wildlife Service of N.S.W.

The specific objects of the Foundation are to:

encourage private gifts of real and personal property or any income therefrom for the benefit of the National Parks and Wildlife Service

accept, receive, solicit, hold, administer and use any gifts, devises, bequests for the benefit of the National Parks and Wildlife Service.

The Foundation seeks benefactions over several years in sponsorship of the projects to be undertaken. The funds raised will be used exclusively in N.S.W. It is governed by a Board of Directors representative of major interests concerned about conservation in this State.

LEGAL STATUS

The Foundation is incorporated under the Companies Act as a company limited by Guarantee; it is also registered under the Charitable Collections Act.

BEQUEST

A most generous bequest under a will was left to the Foundation by the late Mrs. A.H. Batwell of Sydney. Before her death she allocated the major portion of her estate for the preservation of Australia's natural wildlife including animals, birds and sealife and their respective environments. This is an example which it is hoped will be followed by many others.
